INHERENT RISKS OF EQUINE ACTIVITIES

This notice is to inform you and your invitees about the inherent risks of injury while engaged in horse related activities with My Wild Winds Ranch, LLC., including the fact that horses can behave in unpredictable and dangerous ways that may result in death or injury to persons or property on or around them, such as kicking, pawing, rearing, falling, biting, bucking, and reacting to things like sound, sudden movement, unfamiliar objects, persons or other animals and natural hazards such as surface and subsurface conditions that can cause tripping, falling, and lameness. Horses are unpredictable and caution should be used in approaching, touching, handling, riding, and engaging in horse related activities at Wild Winds Ranch.
